Happy New Fiscal Year 2018


NECA is now in the New Fiscal Year and we are looking forward to a very good year.

PROTECTING YOURSELF

Construction is a high hazard industry that with a wide range of activities involving construction, alteration, and/or repair. Examples include heavy equipment construction, bridge erection, roadway paving, excavations, demolitions, and large scale painting jobs. As a construction worker you are involved in many activities that may expose you to serious hazards, such as falling from heights, unguarded machinery, being struck by heavy construction equipment, electrocutions, silica dust, and asbestos.

Your employer is responsible in providing you with a safe and healthful work environment that is free of recognized hazards. As an employee you are responsible for your personal safety while on the jobsite or while performing your tasks and duties.

These are the Top 10 Most Frequently Cited Construction Violations – 2016

- 1. Duty to have fall protection
- 2. Scaffolding
- 3. Ladders
- 4. Fall protection training
- 5. Eye and face protection
- 6. General safety/health
- 7. Head protection
- 8. Aerial lifts
- 9. Fall systems criteria and practices
- 10. Excavation

By looking at the list, ask yourself, "How many of these tasks I'm I doing?" Think about what you are doing to prevent an accident or injury while performing these tasks.

Here are some more tips on how to prevent accidents and injuries.

- Know your rights as an employee.
- Know your employer's responsibilities.
- · Get trained & educated.
- Report hazards and unsafe acts to your supervisor.
- Report all near-misses to your supervisor
- Report all accidents and injuries, no matter how minor.
- Report all near misses.
- Plan, plan, plan......

Keep in mind, all accidents are predictable and preventable. When you recognize a hazard, do something to eliminate the hazard. don't wait for someone else to fix it. Notify your supervisor so the hazard can be addressed and corrected.


