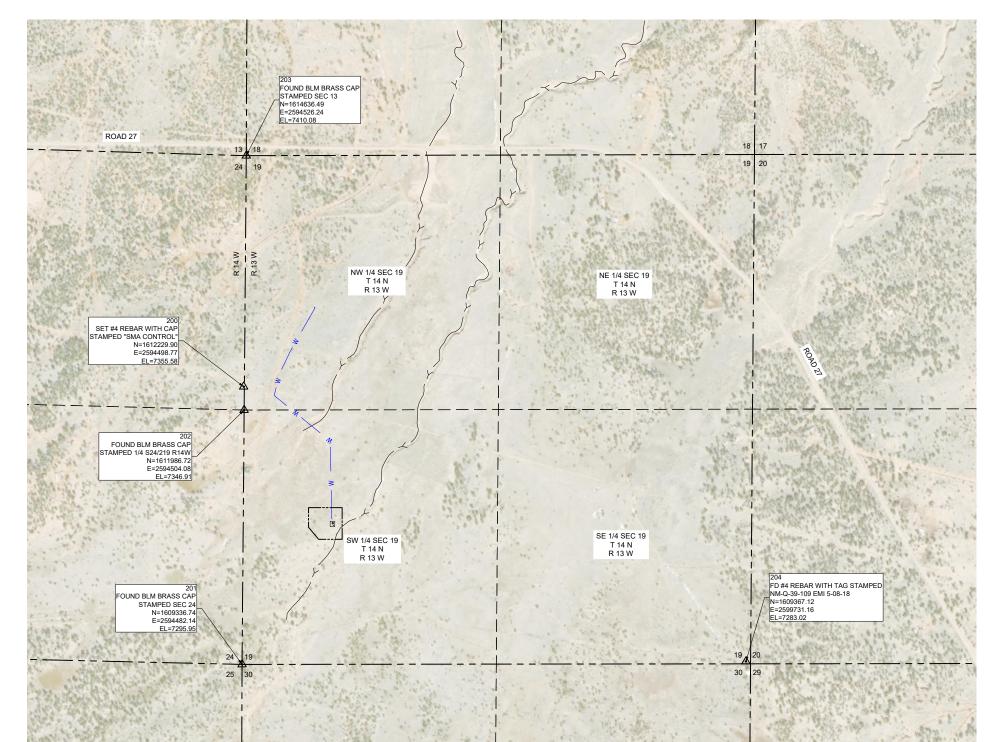

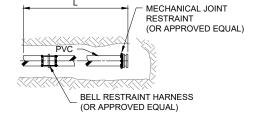


PLAN VIEW JOINT RESTRAINT FOR MJ ELBOW

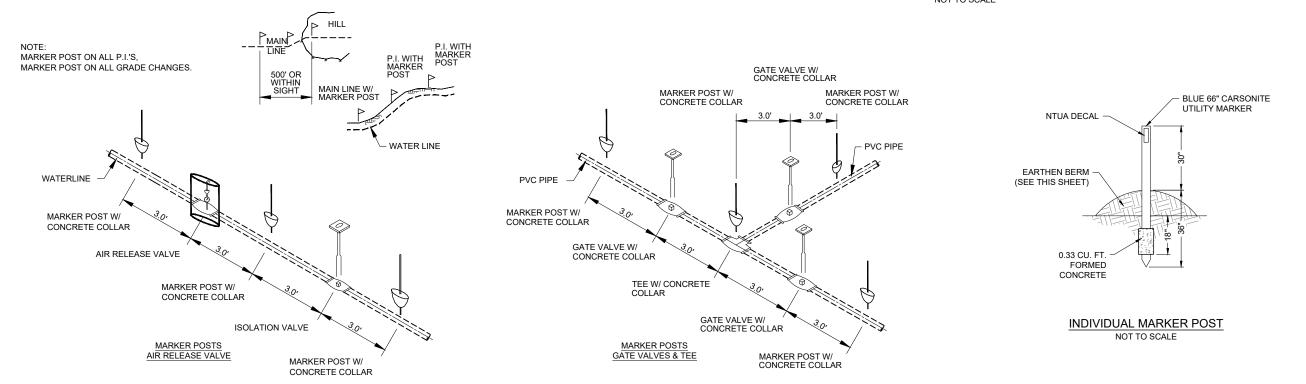

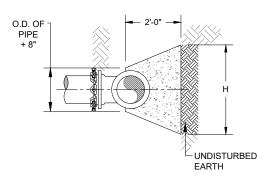
PLAN VIEW CONCRETE BLOCKING FOR TEE

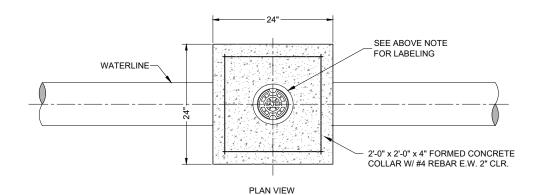

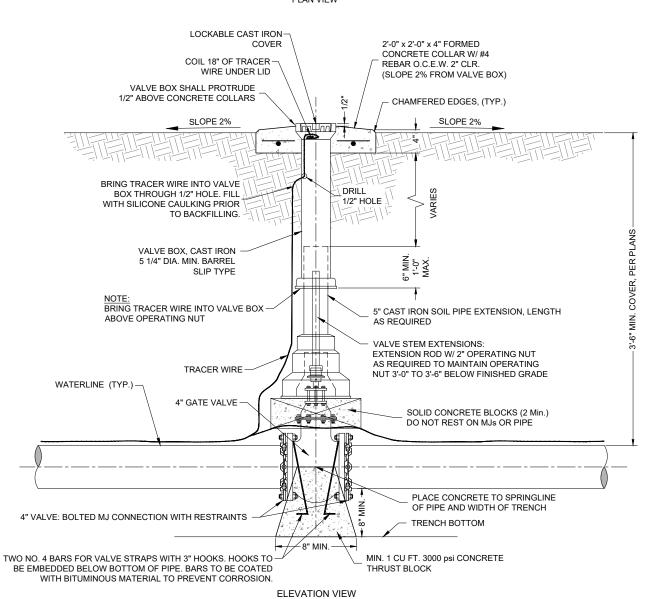

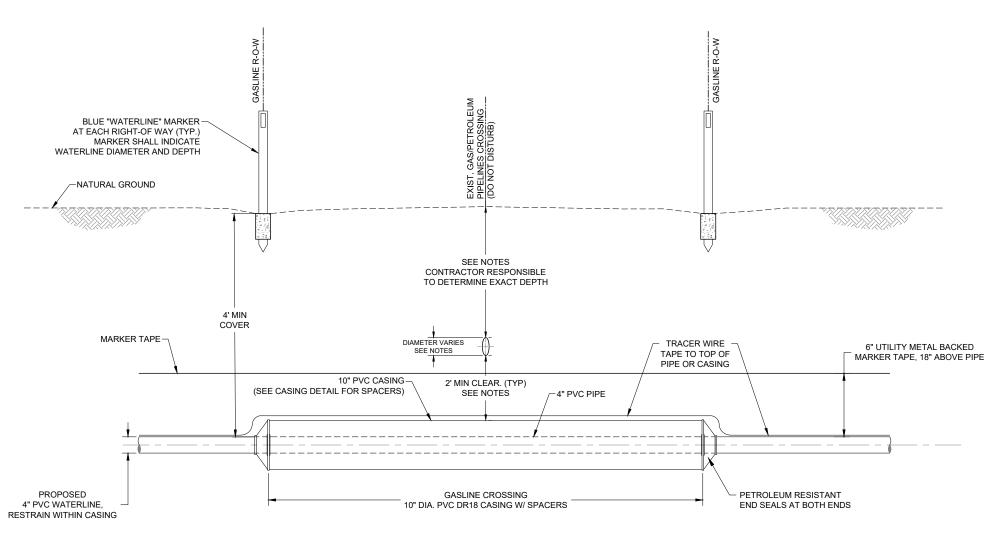

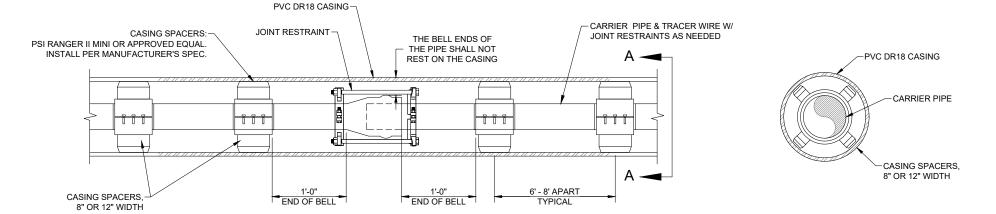

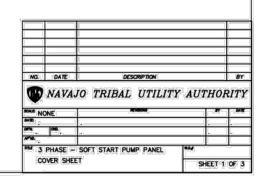
