From Shiprock, NM: Starting from the US HWY 491 and US HWY 64 (south) intersection, drive south on US HWY 491 for 44 miles. Turn right (west) on to NM HWY 134 for 180-feet. Turn left (south) on to Old Hwy and Indian Service Route 32 for 0.4 miles to the Sheep Springs Chapter Complex.

Such request shall be submitted not less than 60 days prior to the scheduled date for bid solicitation and shall include detailed information on the anticipated construction classifications, nature' of the project and completion plans...."
