This is ADDENDUM No. 3 to the CONTRACT DOCUMENTS FOR CONSTRUCTION OF THE TSE'II'AHÍ WATER LINE EXTENSIONS PROJECT, bid package published April 2024. This ADDENDUM No. 3 consists of two (2) pages. All interested bidders are hereby notified of the following clarifications, changes, additions, modifications and deletions to the Contract Documents, as described in detail below:

Item 1. Change for Bid Opening

Separate sealed BIDS for the construction of the TSE'II'AHÍ WATERLINE EXTENSIONS, Navajo Nation Bid No. 24-03-3298LE, will be received by the OWNER at the office of the ENGINEER, Souder, Miller & Associates, until 2:00 PM (Local Time), TUESDAY, MAY 28th, 2024, and then at said office publicly opened and read aloud.

Item 2. Change for Pre-Bid Meeting

Attendance of the Pre-Bid Meeting that was held at the Tse'ii'ahi (Standing Rock) Chapter House, McKinley County, New Mexico on Tuesday, April 23rd, 2024 at 10:00 am (MDT) is no longer a requirement for eligibility to submit a bid.

Item 3. Clarifications in Response to Submitted Questions
